With MEDS®, not only can you create and submit the case electronically, but you can produce the forms and sign them electronically too. The system was designed from the worker's perspective and is simple and intuitive to use for anyone transitioning from the paper process or from other systems. You will notice increased productivity the first day you start with MEDS®.

The Application Process

A tabbed interface allows for simple, organized data entry, and data validation ensures all entries are in the correct format. Much of the patient data can be imported into the system.

You can then create application and ancillary forms with pre-filled data with the touch of a button. Forms can even be electronically signed and "saved as image" for a completely paperless process.

Many pre-configured reports are available as well, including those that financial counselors and management are used to, and our development tools allow for additional report requests to be completed quickly and efficiently. Reports can be printed or exported to Excel®.
